

To expand and aid our understanding of the timely and important issue of immigration, the League of Women Voters of Santa Barbara is hosting a Community Forum on the subject.

Speakers will include:

- Theresa Figueroa, Ph.D., from UCSB's Chicano and Chicana Studies Department, presenting an overview of the issue of immigration, contributing factors and influences.
- Arno Jaffee, a local immigration attorney, speaking about legal issues facing immigrants and communities.
- Gabriela Rodriguez from Future Leaders of America, a youth leadership development organization, discussing obstacles and programs for young people in particular.

The League of Women Voters of the United States believes that immigration policies should promote reunification of immediate families; meet the economic, business and employment needs of the United States; and be responsive to those facing political persecution or humanitarian crises. Provision should also be made for qualified persons to enter the U.S. on student visas. All persons should receive

fair treatment under the law.

The League supports federal immigration law that provides an efficient, expeditious system (with minimal or no backlogs) for legal entry of immigrants into the U.S.

To complement the League's goals, we support federal policies to improve economies, education, job opportunities and living conditions in nations with large emigrating populations.

In a transition to a reformed system, the League supports provisions for unauthorized immigrants already in this country to earn legal status.

The League supports federal payments to impacted communities to address the financial costs borne by states and local governments with large immigrant populations.

The meeting is free and open to the public. Drinks and snacks provided – bring a brown bag lunch and hear experts discuss the issue of U.S. immigration. Please come!

Fifty years ago, I was a senior at the University of Michigan, and a first-time voter. Presidential candidate John F. Kennedy came to Ann Arbor. He was supposed to just spend the night at the Michigan Union - our version of UCSB's U-Cen, which also had a few hotel rooms. We students hoped he'd say a few words, and a mike was set up at the top of the stairs. His plane was delayed, and we were given special dispensation to stay out of our dorms beyond curfew. Three hours of waiting outside on that cold night only fueled our excitement. He finally arrived in the wee hours of October 14.

The brief, impromptu speech he gave at 2 a.m. that night has gone down in history as the moment the idea of the Peace Corps was born. Kennedy said,

"How many of you who are going to be doctors are willing to spend your days in Ghana? Technicians or engineers: how many of you are willing to work in the Foreign Service and spend your lives traveling around the world? On your willingness to do that, not merely to serve one year or two years in the service, but on your willingness to contribute part of your life to this country, I think will depend the answer whether a free society can compete. I think it can. And I



think Americans are willing to contribute. But the effort must be far greater than we've ever made in the past."

And as the local news reported, "Kennedy said he was not asking the students for their support in the 1960 campaign, but rather their support for their country in the next decade."

A line of "Kennedy Girls" in white boaters, including myself, stood behind Kennedy. I was only 10 feet away from him. Members of his entourage apparently stood in front of us, but I don't remember them at all - only that most inspiring speech. UM students took up the challenge and led the way to the establishment of the Peace Corps in March 1961. While I didn't join the Peace Corps, certainly that night helped to define my goals in life. It was truly the experience of a lifetime.

### League members and the Peace Corps

LWVSB member **Juliane Heyman** was the first woman training officer for the Peace Corps when it began in 1961. She has called it one of her "most satisfying and exciting experiences."

## State News Redistricting Commission

A list of 60 finalists for the Citizens Redistricting Commission has been submitted by the Applicant Review Panel to the Majority and Minority Leaders in the State Senate and Assembly. The Voters First Act allows each legislative leader to strike, or remove, two applicants from each of three pools of 20. Legislative leaders must submit the list of applicants to the State Auditor in Sacramento by Nov. 15. The Auditor is required to hold a random drawing from the remaining pools for the first eight commissioners by Nov. 20, 2010. These eight then select the other six commissioners to balance the Commission demographically and by skills, and to ensure that it is impartial.

One applicant from the South Coast remains: Greg Freeland of Santa Barbara, professor and chair,

Department of Political Science at California Lutheran University. Dr. Freeland has recently completed a study of citizen engagement in redistricting; he would make an excellent commissioner.

After the Commission is chosen, it will begin the process of redistricting - assuming that Prop. 27 is defeated at the polls.


