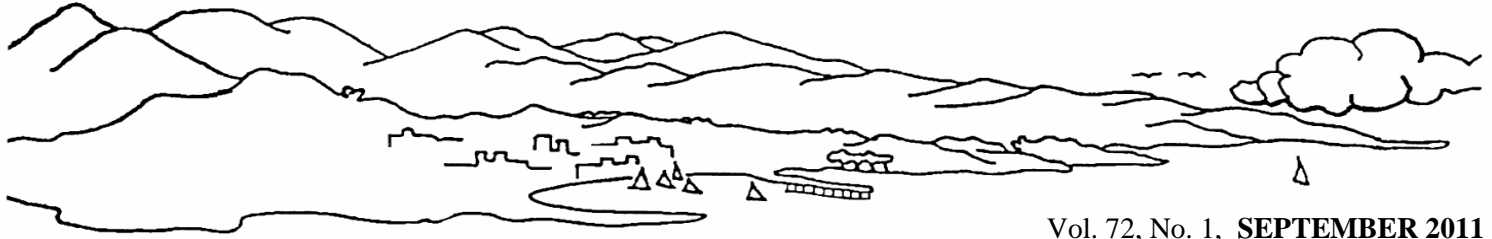

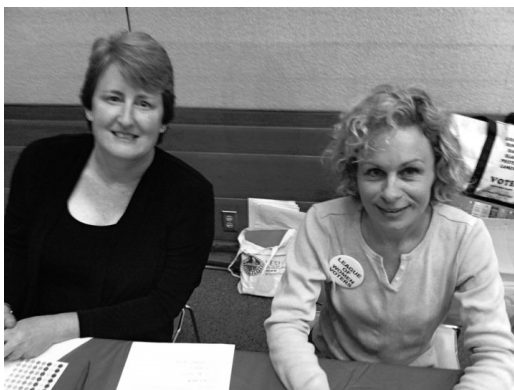
## Meet the League's Co-Presidents

"From housing, to health care, to the environment, to offering voter services, the League of Women Voters of Santa Barbara has been working on issues that affect all of us every day," the co-presidents said. "One of our goals for the new League year is to celebrate the many local coalition partners who are vital to our efforts."

Elected at the June annual meeting, Stacy will be responsible for membership and community education and Beth will work with the league's program and action team.

Beth has been a league member since 2006, serving as secretary from 2008 to 2010 and social policy co-chair in 2010. She was also on the nominating, executive, communications and 90<sup>th</sup> anniversary celebration committees, and represents the LWVSB on the local Pro-Choice Coalition.



She and her husband moved to the area from Chicago in 1999. Beth worked for Direct Relief International for 11 years and is now an independent consultant helping non-profits and individuals with grant writing and special projects.

"After many years of volunteering in literacy in literacy programs, I enjoy helping to promote democratic literacy

with the League president," Beth said.

Stacy came to Santa Barbara in 1993 to study computer science and has been employed at Cisco Systems since March 2000. She has been active in many community organizations, including the Commission for Women and Friends of the Commission for Women.

She was the League's liaison to the Pro-Choice Coalition and vice president for community education. Stacy was also in charge of SmartVoter and organized unit meetings and the 90<sup>th</sup> anniversary celebration of the League.

## State Redistricting - Final Maps are Drawn

After the independent California Citizens Redistricting Commission voted to ratify the final maps on Aug. 15, unchanged from the draft final maps and with only one dissenting vote, the maps have now been approved and forwarded to the Secretary of State. The new districts have displaced over 60 political incumbents.

This is the first time in the history of California that an independent citizens commission drew district boundaries for U.S. Congressional, State Senate, State Assembly and Board of Equalization districts. How will California change? Commissioners said that hundreds and hundreds of people became involved in the process, coming to public hearings, speaking for themselves and for others (people of different backgrounds supporting Hmong and Sikh communities). This was the first time for many citizens and seemed to ignite a landslide of interest in the governing of our state.

California is the first in the nation (again) to adopt this process. Other states are eager to see the process to the finish line and start to address political interest districts and gerrymandering in their own states.

The Commission's entire process has been open and transparent. The public has been able to watch the Commission deliberate, discuss and ultimately draw the lines. Commissioners heard them: over 2,700 members of the public spoke at 34 Commission hearings around the state and close to 20,000 comments were received in writing. The Commission has carefully considered the varied interests throughout the state and has successfully balanced those interests in crafting fair and representative

districts.

*Note:* the Redistricting Commission in 2011 held three public hearings, the maps were published on the Friday before the Labor Day weekend and approved the following Tuesday. Not our best day!

Any legal challenge will be sent straight to the California Supreme Court for review. This provision was written to expedite any legal challenge so a decision could be made on the maps in time for the June 2012 elections.

Republicans announced recently that they may challenge the new legislative district maps. California Republican Party Chairman Tom Del Beccaro has said they may file a referendum for the 2012 statewide ballot. A handful of special interest groups, including the California Friends of the African American Caucus, Mexican American Legal Defense and Educational Fund and the Coalition of Asian Pacific Americans for Fair Redistricting, have threatened to sue over objections to the lines.

“The Citizens Redistricting Commission (<http://wedrawthelines.ca.gov>) has published the final maps, the culmination of seven months of extremely hard work. The League of Women Voters of California applauds the work of both the commissioners and the public. Unlike redistricting in the past, this process has been open, transparent and participatory—a true citizen-driven process. We are confident that this first-ever commission will be a model for the entire nation,” stated LWVC President Jennifer A. Waggoner.

### Santa Barbara County Supervisors Adopt Final Redistricting Map And The Impact of State Redistricting

The County Board of Supervisors adopted a new redistricting map on August 9. This final map established the boundaries for five County district boundaries for the election of supervisors.

This most recent map for supervisorial districts as prepared by Supervisor Salud Carbajal moved New Cuyama from the 5<sup>th</sup> district to the 1<sup>st</sup> district. Guadalupe was moved from the 4<sup>th</sup> to the 3<sup>rd</sup> District with Isla Vista remaining in the district.

The results of the State Commission redistricting for state assemblymember and state senators and congress in the county:

Briefly, the new 37<sup>th</sup> State Assembly District includes the South Coast, Santa Ynez Valley and part of western Ventura County. State Senate District 19 includes Santa Barbara County and western Ventura County and the Channel Islands.

The new 24<sup>th</sup> Congressional district boundary approved by the State Redistricting Commission moves from San Luis Obispo on the north to the City of Ventura on the south, and includes more inland areas than the prior district.

Before adoption of the new boundaries, there were many public meetings and review of several proposed maps prepared by members of the public. *Cheryl Rogers, Member, LWVSB*

## Consensus Workshop: Federal Role in Public Education

LWVUS is conducting a national study on the role of the federal government in public education (Pre-kindergarten to 12<sup>th</sup> Grade) and our Santa Barbara League has been participating in this study. All members are invited to take advantage of this opportunity to provide feedback on critical issues for our public schools.

No formal background in educational policy is needed to contribute to the consensus. Almost everyone is an expert on public education because of their experiences, either personal or through their children, grandchildren or friends. Many of our members are keenly interested in this topic as current and retired teachers, current and former school board members, administrators, and other education activists. Everyone can make a valuable contribution to this process.

The scope of the consensus includes funding and equity issues as well as common core standards and assessments. The consensus questions were developed by a national study committee and approved by the LWVUS Board. Each participating League will discuss the same questions. Necessary background materials will be provided in advance online and at the meeting itself.

The results of all local consensus meetings will be forwarded to the LWVUS. If the responses demonstrate that there are areas of agreement among members, the national Board will develop a position on the role of the federal government in public education. The League will then be able to influence public policy decision-making, for example, by lobbying Congress for or against a bill on education. LWVUS may also ask local members to assist in such efforts by calling or writing their members of the House or Senate.

**The consensus workshop will take place on Saturday, October 1 from 9 a.m. to 3 p.m. at the Marmalade Café meeting room. The café is located in La Cumbre Plaza straight across the parking lot from Vons. Lunch at a cost of \$10 each will be provided.** It's important to attend the entire workshop if you can since questions will be discussed throughout the day.

The link below is to the 15 consensus questions that are divided into 3 areas: 3 general questions; 6 questions on Common Core Standards; and 6 questions on Funding and Equity.

### LWV Observer Corps: Now more than ever we need government watchdogs!

Nothing strikes fear in the hearts of an elected or appointed official more than those few words on your lapel button: “League of Women Voters: OBSERVER.”

The Observer Corps keeps elected and appointed officials on notice by ensuring that issues facing the community are being handled “in the sunshine.” An observer is an individual who attends a governmental meeting, notes what happens at the meeting and reports back to the League.

Once I took up the challenge of reenergizing our local Observer Corps, several “vintage members” told me that this was how they began their association with the League of Women Voters.

The Observer Corps is a great vehicle for piquing your interest in the political arena, hearing from the citizens and elected officials *directly* while at the same time learning and advising the local league of hot topics.

Ideally, the observer corps monitors both the issue being discussed as well as the process by which they are being

discussed—i.e. adherence to the Brown Act, attitude toward the speakers, and behavior of the official. Observers usually do not “act” upon the issues at the meeting. So if you are gun-shy of public speaking, you

will like this independent, low-key role. If you can attend a meeting or portion of a meeting, fill out a form and relay the information to the appropriate league person—you are just the

person we need.

I will coordinate the Observer program by training you, introducing you to the agency you will be observing and helping guide you through the experience. You may attend meetings sporadically, attend several meetings or share the duty with other observers. If you have a special interest; say, you want to observe the Goleta Water District meetings—then you are welcome to follow your heart...please join us.

## Clean Air

LWVUS has continued its defense of clean air, launching the Clean Air Promise campaign and a new website, <http://peoplenotpolluters.org>. Please make the Promise yourself, and send a message to our Senators urging them to make the promise and stand firm on protecting our air. See the website, or call me for further information.

In late July, the national League and coalition partners sent a letter to the House of Representatives urging House members to support the "Capps amendment" to the appropriations bill for EPA and the Interior Department, H.R. 2584. This amendment would protect Americans from mercury, soot, and other life-threatening toxic air pollution from power plants by striking a rider delaying the Mercury and Air Toxics Standard. Power plants are the largest manmade source of mercury, soot, and smog pollution in the U.S., and standards to limit these toxic and deadly air pollutants are long overdue. In particular, mercury exposure can cause brain damage and learning disabilities in developing fetuses and young children, and it is estimated that each year over 400,000 newborns are exposed to potentially harmful levels of mercury. LWVSB would like to extend our thanks to Rep. Lois Capps for this important effort to protect health.

## Fracking

"Fracking" - horizontal hydraulic fracturing of oil and gas wells to increase their productivity - was the impetus behind a resolution on "safer drilling and mining," which passed unanimously at last year's LWVUS Convention. It has recently become an issue in Santa Barbara County, and at LWVSB's Annual Meeting, some of our "Advice to the Board" was to

keep an eye on the issue. We've been keeping track of local developments to see what action might be needed. On the state level, LWVC supports AB 591, which would require disclosure of toxic chemicals used in fracking operations, as well as how much water is used and other important data.

On the national level, LWV has recently taken action on regulations rather than legislation. From the press release for the coalition, *Earthjustice filed [a] petition on behalf of Environmental Defense Fund, The League of Women Voters and more than 100 other groups from across America... The petition asks the EPA to draft rules that—for the first time—would require manufacturers and processors of drilling and fracking chemicals to conduct testing and produce health and safety data needed to evaluate the health and environmental risks of their substances and mixtures...*

*"People are understandably concerned about the potential health impacts posed by fracking. Here in Pennsylvania and across the region, as the pace of drilling has skyrocketed, so too have reports of illness and pollution," said Roberta Winters of the League of Women Voters of Pennsylvania. "The League of Women Voters is deeply concerned about this national issue that threatens the environment and public health. The state Leagues of New York and Pennsylvania are working hard to educate the public about the environmental, public health, and economic impacts associated with fracking. As we continue to advocate for public participation and transparency, we encourage citizens to make their voices heard to regain necessary environmental protections. Our nation's leaders are on notice that our organization, and more than a hundred others nationwide are pressing for swift action on this petition."*
