

September Community Forum Debating The Merits Of Ballot Measure P 2014

Wednesday, September 17, Noon-2 p.m Louise Lowry Davis Center, 1232 De La Vina Street

We will start our program year with a community forum on the most appropriate topic of the season – the election. The program will focus on Measure P, officially titled The Healthy Air and Water Initiative to Ban Fracking.

As we many of us know, it bans much more than fracking; rather it bans" all advanced techniques" that can be described as "high intensity well stimulation." The ban would be effective for future on-land oil and gas projects in the unincorporated parts of Santa Barbara County, most importantly those in the north county.

The forum will give us an opportunity to learn about this very hot topic that will be much debated between now and Nov. 4. The debate will start with a description of the current situation in the oil fields of Santa Barbara County as well as the state and county regulations that apply. **Kevin Drude**, who heads the county's Energy and Minerals Division will provide this. Then the pro and con advocates will present their reasons why you should vote their way followed by rebuttals and questions from the floor. **Dave Davis**, the executive director of the Community Environmental Council, will speak in favor of the measure and a representative of the Vote No on P campaign will speak against it.

All League meetings are free and open to the public. You are encouraged to invite your friends. Bring your brown bag lunch; cookies and beverage will be provided. Parking behind the center, off Victoria Street, is free during the meeting.

October Community Forum: Let the League Help You with the Ballot Measures

Wednesday, Oct. 15, noon-2 p.m., Louise Lowry Davis Center, 1232 De La Vina Street

Hold on to your ballot, because at our Oct. 15 Forum, we will be discussing all the League recommendations on state and local ballot measures.

One of the most important measures on the Fall ballot is now Proposition 1. It was previously Prop. 43, the Water Bond, and was opposed by the League. It has been extensively amended, and LWVC is now reconsidering whether it will take a position on it. The League is supporting Prop 2, the Rainy Day Fund for State Budget Reserves. LWVC believes that this will take an important step toward fiscal discipline in state government. It requires the state to make contributions to a rainy day reserve fund and pay down debts and liabilities when times are good. In bad times those reserves can be used to reduce cuts in essential programs like schools, health care, public safety, etc.

The League also supports Prop 47, the Safe Neighborhoods and Schools Act, which will ensure that prison spending is focused on violent and serious offenses, and will maximize alternatives for non-serious, nonviolent crime. The savings generated will be invested in prevention and support programs in K-12 schools, victim services and mental health and drug treatment. The state League has not made any recommendation about Propositions 45, 46 and 48 because we do not have League positions that cover them. We will also discuss the local League's position on Measure P, the Ban on Fracking ballot measure on the Santa Barbara County ballot, at that October Forum. Since some of these ballot measures may need more explanation, we hope that this program will be a real help in filling out your ballots. Our local League's contact person with state and national League, Linda Phillips, will moderate this forum, and invite people who have studied the measures to discuss them with you.

Save this forum date, and know that help is on the way! As always this meeting will be free and open to the public. Bring your lunch and a friend. Beverages and desserts will be provided.

Measure P, The Healthy Air And Water Initiative

For some time now the oil industry of northern Santa Barbara County has been in decline as the easily accessible resource has already been extracted. But in recent years various techniques have been developed to give a capability to obtain oil and gas from previously impossible formations. Predictions have been made of another oil boom in the North County. Fracking, cyclic steam injection and acidization are the techniques we hear about the most.

Fracking, which uses high water pressure and chemicals to break open cracks in oil bearing shale, has been much in the news but it did not work well when tried here. It is not expected to have a future in this county. Cyclic steam injection is the current favorite with a number of applications made to the county for wells of this type. Large amounts of steam penetrate a diatomite layer and soften the oil so it can be extracted. Last year Santa Maria Energy's proposal for such a project in Orcutt resulted in very contentious hearings on the issue of the large amounts of greenhouse gases to be emitted when making the steam. Acidization uses acids of various kinds, sometimes under pressure, to dissolve the matrix and/or open fractures in order to increase the flow of oil. It is not a big concern in Santa Barbara County at this time.

Public reaction in the nation to these practices has been mixed. Some people focus on the economic benefits of the stunning increase in domestic hydrocarbons while others complain about the environmental damages that have resulted from their use (mostly fracking). Concerns of the latter type led to the passage in this state of legislation requiring stiffer regulation of such operations. The Division of Oil, Gas and Geothermal Resources has issued interim regulations and will issue permanent ones by the end of the year. Workshops in Santa Maria have been part of the process. Additionally, this county has amended its land use code to establish that its permits are not automatic and must be preceded by an environmental assessment.

Ballot Measure P 2014 would enact a ban on the use of "High Intensity Petroleum Operations" in all unincorporated areas of Santa Barbara County. The prohibited operations are defined as: either those that increase the permeability of the formation, such as acidization or fracking, or those that simply aid the flow of oil by injecting water, steam or other substances. Exemptions are allowed for owners or operators who can show that the ban would cause a taking of their property or that they have a vested right to conduct a high intensity operation.

The proponents of Measure P 2014 say:

- This initiative would head off potentially large increases in air pollution including benzene, toluene, methylbenzene, xylene, particulates and greenhouse gases. The greenhouse gases emitted could negate the county's Climate Action Plan
- High intensity operations use and degrade too much precious water
- Above ground spills and below ground leaks into aquifers could result in serious water pollution problems
- Steam injection is the most energy-intensive form of oil production and is linked to seeps and sinkholes
- · Earthquakes have been caused by the large amounts of wastewater from extreme oil extraction deep underground
- This ban will not affect current operations and extreme oil extraction will generate very few jobs
- This measure has been drafted to deal with the issues of vested rights and the taking of economic value of property; if necessary
 an exemption can be granted

Opponents of Measure P 2014 say:

- Water used for steam injection is not drinking water; instead it is wastewater separated from the produced oil or effluent from a sanitation plant
- The oil industry is an important part of the north county economy and this ban will result in a great decline in the industry and the loss of tax revenue that supports the county, schools and special districts
- Unemployment in the North County is high the area cannot afford to lose current high paying jobs or the jobs that would potentially open up with the use of these new techniques
- "High intensity operations" are simply evolutions of techniques that have been standard practice for decades
- The legal liability imposed by Measure P on the county is potentially the greatest it has ever faced, according to the county counsel
- Science-based regulation such as what the state is developing is a better option than a complete prohibition based on anecdotal evidence from elsewhere
- Oil is needed as an ingredient in the manufacture of many products and such use is not a factor in global climate change

League Studying Santa Barbara City Council Elections

A motion was passed at our Annual Meeting to conduct a local update study of our position on Santa Barbara City Council elections--district v. at-large elections or other election options.

The California Voting Rights Act (CVRA) of 2001 enacted various intended reforms to be inclusive of all groups in the voting process. "Racially polarized voting" has created legal problems for various cities. To date the State Supreme Court has not had a case presented that would allow the Court to rule on the legality of this part of the Act.

At the end of July, local attorney A. Barry Cappello filed a lawsuit against the City of Santa Barbara on behalf of Cruzito Cruz and several others. This suit alleges that the City suffers from "racially polarized voting," among other issues. There are many issues involved in the suit and within the CVRA. The City is looking at spending upwards of \$500,000 to defend itself against this action.

The League committee so far consists of Betsy Cramer, Connie Hannah, Shane Stark, Lindsey Baker, Susan Shank, Marty Blum and Vicki Allen, with Amanda Pelch as chair. We are continuing to look for a few more volunteers.

At our meetings we have discussed the focus and process of our study. The LWVC has good directions on conducting such a local study, but it is a daunting task. The exact direction is complicated by the suit and our previous local League position. In 1968 the City of Santa Barbara went from district to at-large elections. Our League then took a strong position for at-large elections. Our local League cannot change that position without further study and ultimate consensus from our membership.

It would be hard for us to not participate in this current debate. Much to the credit of LWVSB, with our current and past members, we have participated in many of these discussions throughout the years.

The Sustainable Communities Committee's History

In the late 1990's, a commission called by President Clinton began discussing a new concept for this country--"what will be sustainable in the future?" Suddenly everyone was talking about it. In 1998 the Santa Barbara League decided to form a Sustainable Communities Study Group, which has continued to meet for 15 years.

A little later the national League did a major study and found that many (or most) League positions would contribute to sustainability in the long run, and so we did not need a new position, but needed to use our existing positions to promote this goal.

In the beginning we looked at a global perspective on the question, guided by former president Lessie Nixon. Many presidents of this League have worked with the committee from the beginning because this has proved to be an essential part of our work. Soon after, under President Beverly King in 1999, we began to consider the Entrada Hotel's permitting process and impacts. That led us into our only two lawsuits and years of hearings. You will note that that issue is just now being resolved.

Over the years we have attended countless meetings concerning land use planning and General Plans and have usually offered a League perspective on the issues. We were very active while the new City of Goleta designed their original General Plan, and we endorsed it. So many changes have been made in that Plan that now we are very concerned about developments in that community. This year we have been very fortunate to have had as members: from Goleta, Margaret Connell, former mayor, Bill Shelor, former planning commissioner and Barbara Massey, activist par excellence, working with us, and we will continue to follow developments there in the coming year.

In 2006-2007 we had participated in 21 different issues, with the help of two-term president Cathy McCammon. In 2008, we changed our name a little when it was determined that we had been doing the work of a League committee all the way along! We are very grateful for the work of the Education, Water and Social Policy Committees, because they narrow the field for us a lot.

In recent years we have merged with the Energy Committee, and that has given us the invaluable guidance of two-term president Jean Holmes. We will continue our work on all aspects of oil development and promotion of the alternative forms of energy that we really need now.

We invite new or continuing League members with interest in any of these subjects to join us this year. We meet at the Encina Royale clubhouse near Fairview Avenue because our meetings often last two hours on a Friday morning and there is unlimited parking there. This has always been a large and energetic committee, and we cooperate with UCSB, CPA, the Goodland Coalition, the Environmental Defense Center and other organizations which are currently working with governments on these same issues.

New LWVC President Helen Hutchison To Fight for Voting Rights and Engage Californians in Civic Life

Last month, Helen Hutchison of Oakland was appointed President of the League of Women Voters of California and the League of Women Voters of California Education Fund to serve a one-year term. She promises to fight for voting rights, responsible public policy, and to lead the charge in providing accessible, nonpartisan election information to all Californians.

"I am thrilled to lead our grassroots members and supporters in the fight for voting rights and will remain steadfast in our commitment to providing nonpartisan election information for California's diverse population," Hutchison said. "We will continue to work hard for smart and responsible public policy to make our Golden State a fair and vibrant place for us all," she added.

Energy Issues in the State Legislature

Two bills on different energy issues merited League attention this past summer. One bill, AB 2145, ostensibly was tweaking the basic authorization for Community Choice Aggregation programs. These programs, which are just getting started, can serve as a means of increasing our access to green power and the county and the cities of Goleta and Santa Barbara have incorporated them into their long range climate action plans.

But AB 2145 in fact incorporated poison pills, for example, a requirement that prospective customers be told what rates they will be charged over the next five years while the big utilities have only to make a *projection* of their rates – no certain commitment for them. This, combined with other requirements amounted to an attack on the CCA concept, and LWV California decided to oppose the bill.

The other proposal is one we support--SB 1096 authored by our state senator, Hannah-Beth Jackson. This bill deals with offshore oil and gas leases in the tidelands three miles out along our coast. New leases were closed off by the establishment of a sanctuary in 1994, however with an exception for situations where production from a nearby federal lease includes tidelands oil that flows over to the federal wells as the pressure is lowered.

In contrast to the situation in 1994 there is now only one area where this exemption might apply. That is offshore Vandenberg Air Force Base in an area so ecologically rich the state has created a marine reserve there. Senator Jackson was undoubtedly influenced by the latest Tranquillon Ridge proposal (this one to slant drill from the base), but regardless of the outcome of this one project, it would be good to make the protection of the Coastal Sanctuary complete for now and the future.

At this writing both bills have been placed on Appropriations Committee suspense files and if they pass out successfully they must return to their house of origin for final passage there. Stay tuned.

A Report on the LWVUS Convention

One unusual event this year was a contested race for League President. Evidently, the slate proposed by the nominating committee is usually elected automatically. However, this year, President Elizabeth MacNamara, who has been on the national board since 2006 and President for the last four years, was challenged by Deidre MacNab, who is President of the LWV Florida. A forum was held with the two candidates, followed by a secret ballot election on June 9. There was an excellent turnout and the result was a roughly 2 to 1 victory for Elizabeth MacNamera.

A number of excellent outside speakers addressed the convention. One of these was Annise Parker, the Mayor of Houston, who spoke on the first full day. She is an enthusiastic and proud League member. She is also funny. She said people never get elected by promising NOT to do something. She added that only people who are angry or upset talk to city hall, not people who are happy.

Stephen Murdock, former director of the Census Bureau and now the Texas Demographer, spoke about demographic trends in Texas and the U.S. He first pointed out the dramatic shift in population to the West and the South, which together now account for over 60 percent of the U.S. population. He also said that from 2000-2010 there was a huge increase in the number of Hispanics and almost no increase in Anglos. By 2050, only persons age 50 and over will be majority Anglo.

He concluded that education still pays off in terms of employment and earnings, and that Hispanics are very underrepresented in the college age population. He argued that the future of the U.S. is tied to minority population and it is critical to invest in early childhood education.

The adopted agriculture position closely reflects the local consensus findings. Two important resolutions passed—one in favor of a price on carbon emissions as part of an overall plan to improve energy efficiency and the other in favor of restoring voting rights to felons who have been released from prison. A new position was adopted on human trafficking, which will apply to all League levels—local to international.

According to Elisabeth MacNamera, "We have committed ourselves to going back home, not afraid to get in the way of big moneyed interests on voting rights, campaign finance reform, redistricting and climate change. We have committed ourselves to growing and strengthening the League by broadening our Membership and Leadership Development (MLD) network."

The Personal Histories of Our 50-Year Members

The Channel Voter is continuing to tell the personal stories of some of our amazing members who have been Leaguers for 50 or more years.

Lillian P. Lovelace

I was born and lived my early years in Santa Monica. My family was very active in political and social justice issues during the turbulent 30s and 40s, taking a very active role in the establishment of the consumers cooperative wholesale and resale business in California after its beginning in Sweden. I chose to attend Antioch College, founded by Horace Mann in Ohio, because of its motto of "Be ashamed to die before you win some victory for humanity." I majored in psychology and early childhood education and because of illness in my family, I transferred to UCLA. I finally graduated from Antioch in Santa Barbara in 1989, with children and grandchildren in attendance.

My husband, Jon, and I lived with our four children in Whittier from 1957 until 1972. The LWV was a very important part of my life there as I was chairing many committees and finally was the Whittier League president. We moved to Santa Barbara in 1972 and I continued my membership in the League, but was so busy going back to college to finish my degree in the Antioch adult and graduate school that I have not been as active here. I have kept up my membership and support for League at the national, state and local levels.

I am now trustee emeritus of the board of governors of Antioch University, from which I received an honorary doctoral degree. I also serve as emeritus trustee on the boards of Antioch Santa Barbara and Antioch Los Angeles. I am also on the board of Los Angeles Museum of Contemporary Art, The Capital Group Foundation, the Brain Mapping Medical Research Organization at UCLA and a trustee of the UCSB Foundation. Also at UCSB my husband and I started the Martin Marty Lectureship for the study of religion and public life and I am a member of the chancellor's council. I have served on the board of the Santa Barbara City College Foundation and Phoenix of Santa Barbara, and am a life honorary trustee at the SB Museum of Art. I was also president of the Council on Alcoholism and Drug Abuse in Santa Barbara.

I am glad indeed that I was able to participate in the League earlier in my life, as it was an invaluable education in political and governmental action and a lesson in non-partisan research as well as the bi-partisan decision-making process that is hard to find in today's political world.
