

What's Up with the Plains Oil Pipeline?

Correction: The Channel Voter sent earlier today had the correct date, but the wrong day of the week for this Community Forum.

The forum will be on **TUESDAY**, **May 16**, beginning with the screening of a 56 minute documentary film by Gail Osherenko, **BROKE: THE SANTA BARBARA OIL PIPELINE SPILL OF 2015**, followed by a panel discussion of three applications by Pacific Pipeline Corp. (the current owner of the pipeline) and efforts to restart Exxon's platforms off the Gaviota Coast. On April 26, the Santa Barbara Planning Commission rejected—on a 3-2 vote—the pipeline company's application to install 16 new automated safety valves. The applicants are likely to appeal that decision to the Santa Barbara County Board of Supervisors.

The forum will be held from noon to 2pm at Direct Relief Headquarters, 6100 Wallace -Becknell Road, Santa Barbara. Bring your brown bag lunch and a reusable cup or bottle for water.

A representative from Exxon has been invited to join the panel but is not yet confirmed.

One of the permit applications would authorize Plains to transfer ownership of the pipeline to Exxon. Exxon plans to transfer the pipeline to a company that has stated that it plans to reopen the pipeline. That permit has been approved by the Planning Director, but the decision has been appealed by the Environmental Defense Center (EDC) on behalf of Get Oil Out! (GOO!) and Santa Barbara Community Action Network (SBCAN). Another application is for a smaller diameter replacement pipeline, and the third is for adding safety valves to the still damaged and severely corroded pipelines 901 and 903.

The League's Sustainable Communities Committee is sponsoring the forum, along with SBCAN, Gaviota Coast Conservancy and EDC. The pipeline applications were the topic of concern at the recent SusComm meeting on April 7, focusing on why the proposal is being made to add valves to an already corroded pipeline.

I highly recommend seeing Gail's excellent film because it provides a very strong case against and broadens the suspicions of this Plains proposal to possibly reestablish the defective pipeline to deliver oil again. Since this will be our first in person forum this year, we are hoping for a large turnout by League members and guests.



When that meeting adjourns, the party will begin, with a luncheon, and recognition of long-time Leaguers and past presidents, community leaders, and other friends of the League.

The League Goes to County Budget Hearings

Last week hearings were held with the Santa Barbara County Supervisors for next year's budget. These occur over several days with department heads and staff addressing the supervisors and citizens with nicely designed slide presentations of their departments' recent accomplishments and their plans for the future providing that the supervisors will assure that they have funding to make change happen. The presentations end with a meaningful quote selected by each department—actually it's a nice touch to serious business.

Our League committees were especially interested in the reports presented by Behavioral Wellness, Public Safety (Sheriff and Public Defender), and Planning and Development. We prepared letters for some of these departments and made public comments. The hearings are televised and "Zoomed" and are available again a week or so later as a recorded video through the Board of Supervisors' website. The slides used by each department are also available on the County's website.

This year our League collaborated with CLUE-SB (Clergy and Laity United for Economic Justice) and NAMI (National Alliance on Mental Illness) in making comments for behavioral wellness. After a very moving public comment period by families of persons who have mental illnesses and have been affected by our Public Safety and Behavioral Wellness departments, the League/CLUE Workgroup supported those families who want help, not jail time for their family members. Housing, therapy or care without traumatic incarceration are tops on the list of needs this community has.

We sent a letter to the supervisors and also made public comments at both the hearing for Behavioral Wellness and for the Public Safety budgets which include the Sheriff and the Public Defender. We also participated in the hearings for Community Resources and Public Facilities, which include Planning and Development (otherwise known as Housing), and Community Services (which includes some services for housing).

We recommended a "permanent, steady source of funds for affordable housing, prioritizing countyowned property for lower income housing, and tenant protection and fair housing services." And, we thanked the supervisors for their recent work in passing future protections for tenants after the massive eviction of hundreds of tenants in Isla Vista in March.

Budgets may not be published until early summer, so stay tuned. We'll be interested in seeing how they are decided and whether or not their decisions line up with our recommendations.

Voter Service Team Looks Ahead

The LWVSB Voter Service Team met on April 26 via Zoom to discuss what we will do in 2024. We discussed the following topics:

• Voter Registration and Voter Turnout

Because such a high percentage of eligible voters in Santa Barbara County are already registered to vote, we will concentrate next year on increasing voter turnout and pre-registering high school students.

We have a new partnership with the Future Leaders of America, a group of Latinx high school students. Daniel Gonzalez, their Outreach Coordinator, and student members of their group will help us pre-register students who have just turned 16 at high schools in Santa Barbara, Goleta, and Carpinteria.

We also will set up a table at the Farmers Market on Saturdays close to the elections – the Primary in March 2024 and the Presidential Election in November – to have people check their voter registration status (to make sure it's up to date), answer questions people have about their ballots, and encourage people to vote.

Voters Edge

Bonnie Lassen, Marian Slater and other members of the Voter Service team will contact candidates running for office to encourage them to put information about themselves in Voters Edge. We got very high participation by candidates running for office in the midterm elections.

• Candidate Forums

We will go back to having Candidate Forums in person in 2024 prior to the Primary in March and the Presidential Election in November. We will try to have them in a prominent place in SB, such as the Woman's Club. We also will have TVSB cover the meetings and record them so that we can livestream them on our Facebook page and post the recordings (in both English and Spanish) on our YouTube channel for later viewing.

• Pros and Cons Forum

Early indications are that there will be a LOT propositions and ballot measures on the ballot in November 2024, so we will plan to have a Pros and Cons Forum in September 2024 to help voters sort them out and discover who is supporting them.

• Easy Voter Guides

Members of the Voter Service Team will help us distribute these guides (versions in both English and Spanish) to many locations throughout the county prior to the Presidential Election in November 2024.

• National Voter Registration Day

The focus on Tuesday, Sept. 26, 2023 (and again in 2024) will be on our new program to pre-register high school students.
