**LWVSB Co-sponsors Virtual Forum on Health Reform and Social Justice: Wednesday, Oct. 6 from 6-8 pm**


The full title of this important Forum is: “Health Reform & Social Justice: Opportunities for Reducing Inequity and Addressing Health Disparities: An evening with Dr. Susan Rogers, President of Physicians for a National Health Plan (PNHP).” (see email for graphics) It is hosted by the League of Women Voters Davis Area.

Dr. Rogers’s presentation will include an overview of the U.S. healthcare system through a social justice lens, followed by a discussion highlighting disparities resulting from our current policies and opportunities to improve inequities through health reform. The forum will conclude with an audience Q&A.

Dr. Rogers, a Fellow of the American College of Physicians and Assistant Professor of Medicine at Rush University, spoke at the June California League of Women Voters Annual Convention, providing the presentation: “Health Care: Inequities and Opportunities.”

This forum, co-sponsored by several Leagues, aims to educate voters about our current healthcare model and how it impacts local care access, affordability, quality and equity. Our guest speaker provides insights into how health reform can improve each of these to optimize community health and wellness. The LWVDA supports the National League healthcare positions in support of an affordable, accessible, quality, and equitable health care system, critical for the health, safety and economic security of all communities. Becoming an informed voter is fundamental to ensuring the engagement needed to affect meaningful reform. The future of our community health and healthcare systems will rely upon votes cast by those with a better understanding of current needs and resources and our opportunities to enact needed change.

## **Join LWVSB at “Housing Santa Barbara Day” Oct. 9 For Education and Dialog About Affordable Housing**

LWVSB is looking forward to having a bigger role in this year’s Housing Santa Barbara Day, conducted by 2nd Story Associates and the Housing Authority of the City of Santa Barbara on Oct. 9, 10 am - 2 pm in De La Guerra Plaza. We are hosting a new “Community Input Tent” featuring interactive exhibits related to our housing crisis from a Diversity/Equity/Inclusion perspective and some ideas for how Santa Barbara can lead the way with innovative solutions.

The back half of the LWVSB tent will host elected officials who will meet with residents to share thoughts related to housing needs. We will also have a voter registration table, a sign up area for our “Walk and Talk Neighborhood Tours,” a City of Santa Barbara map that has publicly owned parcels identified, and images produced by the AIA-SB Charrette providing inspiration for a revitalized State Street. The following workshops will be conducted next to our tent: Accessible Housing, Tenant Rights & Responsibilities / Rental Mediation, Mexican Consulate Workshop (en español), Rent Relief Resources for Tenants and Landlords, Accessory Dwelling Units – Regulations Explained and Financial Literacy – How to Prepare for Homeownership. There will also be a Zoom session at 1 pm on Affordable and Workforce Homeownership.

Other activities include trolley tours of workforce housing, a jazz quartet, food trucks, 30 booths of housing and community service providers, ADU (Granny Flat) vendors and a kids activity related to houses. ## **Member Tour of the County ReSource Center and Tajiguas Landfill: Monday Oct. 11, 1 pm-2:30 pm**

Santa Barbara County is now home to a cutting-edge waste management facility, the ReSource Center. This facility includes a state-of-the-art Materials Recovery Facility to sort recyclables and trash and an Anaerobic Digester to process organic waste. The ReSource Center tour experience will teach you all about these two big operations and how together they recover more than 85% of our waste and also generate green energy to power the facility and parts of our community.

Join a group of League members for a free educational tour of the Resource Center and drive around the Tajiguas Landfill. We will gather at the Resource Center at 12:45pm. The parking lot is large enough,

however, in the interest of reducing emissions, carpooling is encouraged.. Directions and more information are found on this [web page](#).

## **Virtual Santa Barbara Mayor and Council Candidate Forums: Oct. 18 and 20**

## **A Virtual Forum Wednesday, Oct. 20, noon-1:30 pm Community Choice Energy: A Greener Electric Power Option**

October marks the rollout of a South Santa Barbara County electric power option through Community Choice Energy aggregations (CCEs). CCEs are created by groups of local governments to provide a service, in this case electric power. The reason for forming the CCEs is to facilitate stronger action on climate change and to provide funds to support Green House Gas reduction programs mandated by the state. Older CCEs in other parts of CA have been major purchasers of solar energy and the main reason California's record in moving to clean energy is as good as it is. CCEs contract for more clean power, and if possible, more local power than Southern California Edison purchases. The CCE uses the income from the electricity sold to fund local programs to limit climate change and Greenhouse Gasses. This arrangement provides local input into power choices and programs not possible under Southern California Edison.

Different local governments of Santa Barbara County have adopted different CCEs. Santa Barbara City formed a CCE with the support of Lancaster, CA 's CalChoice and the County and other cities of Santa Barbara County joined Central Coast Clean Energy (3CE). Central Coast Clean Energy runs from Santa Barbara County through Santa Cruz County. North Santa Barbara County is part of Central Coast Clean Energy under Pacific Gas & Electric and it rolled out in Jan. 2021.

While each CCE purchases the power, your electric utility still delivers the power through its grid, charges for this service, and handles the billing. In the roll out everyone starts out in the CCE. Customers can opt out of receiving power from the CCE and rejoin their utility if they want to. Historically approximately 94% of electricity customers in California have stayed with their CCEs.

The forum will cover the types of CCEs formed here, their billing costs, net metering rates, programs, and actions on climate change compared to Southern California Edison. The LWVSB supports staying with the CCE because of its strong actions on climate change.

Forum speakers are: Oswaldo Martinez, Central Coast Clean Energy, Alelia Parenteau, Energy and Climate Manager City of Santa Barbara, and Colin Jones, of the League of Women Voters Santa Barbara.

## **Santa Barbara Mayor and City Council Election -**

**November 2, 2021**

Six candidates are running for Mayor of Santa Barbara in November: Cathy Murillo, incumbent; James Joyce III; Matt Kilrain; Randy Rowse; Deborah Schwartz; and Mark Whitehurst. In addition, three City Council seats are up for reelection this fall – Districts 4, 5, and 6. Kristen Sneddon, Eric Friedman, and Meagan Harmon are the incumbents. Eric Friedman is running unopposed. One candidate, Barrett Reed, is running against Kristen Sneddon for the seat in District 4 and three candidates are running against incumbent Meagan Harmon in District 6: Jason Carlton, Nina Johnson, and Zachary Pike.

The City Elections Office will mail ballots to every registered voter who lives in the city of Santa Barbara in early October. In-person polling places will be available as well as drop boxes where you can drop off your ballot if you are not comfortable mailing it in via the USPS. The locations will be listed in the materials mailed to you with your ballot.

LWVSB held a Candidate Forum for the Mayor's race on Sept. 30 and for the SB City Council on Sept. 22. ### **Oil Trucking Decision Follows Protest**

LWVSB joined the Society of Fearless Grandmothers and other organizations to stop ExxonMobil's plan to truck oil on Santa Barbara highways. On Sept. 30 the Santa Barbara County Planning Commission held an all-day meeting and then voted to recommend denial of the trucking proposal to the Board of Supervisors. The planning staff will present additional information to support the denial on Nov. 3.

The proposal was to transport oil by tanker trucks along hazardous California highways so it can restart three drilling platforms off the Santa Barbara coast. The plan calls for up to 24,800 oil-filled truck trips per year on coastal Highway 101 and hazardous Route 166, 24 hours a day, to refineries for up to seven years or whenever a new coastal oil pipeline is completed, whichever is sooner. ExxonMobil's three offshore platforms near Santa Barbara were shut down in 2015 after the Plains All American Pipeline ruptured and spilled thousands of gallons of oil along the California coast.

ExxonMobil's oil trucking scheme is strongly opposed by a coalition of 35 community and conservation organizations, who recently sent a letter urging the commission to reject the project. They cited the project's threat of more offshore oil spills, fueling climate change, and endangering motorists and communities with dangerous oil tanker truck crashes.

"Now is not the time to turn the clock back and return to our old ways of relying on fossil fuels to meet our energy needs," the letter concludes. "The County of Santa Barbara is moving towards a clean energy future by adopting renewable energy targets and joining the Central Coast Community Energy program. Allowing ExxonMobil to resume oil production off our coast will lead to decades of fossil fuel production that we cannot afford."



## **League of Women Voters of California Lawsuit Ends With a Win for Voting**

Victory! California Governor Gavin Newsom just signed #AB796 - a bill to streamline the voter registration process at the DMV. This is a huge win that will make our democracy more accessible, especially for the 3 million eligible yet unregistered Californians. Thank you Governor Newsom for supporting this important legislation.

This bill will:

- +Make permanent the DMV's current practices that were put in place as the result of the League of Women Voters of California v. Annis court case.
- +Improve oversight and transparency of the Motor Voter program.
- +Ensure voter registrations are processed in a timely and equitable manner.

## **Celebrate Hispanic Heritage Month Introducing LWVSB Member Rose Muñoz**

I am truly honored to be asked to share my story with the League of Women Voters. It is with much joy that I invite you to join me in recognition of Hispanic Heritage Month.

I am the daughter of immigrants; my parents came to the United States from Mexico in the 1950's. I was the first in my family to graduate from college and I had an interesting journey to arrive where I am now. When I say 'family,' I am referring to a large extended family. My father was from a family of eight and my mother from a family of 14.

I was sixteen years old when my younger sister was diagnosed with leukemia at the age of eleven. Little did I know at the time how much our life would change and the long-lasting influence that my sister's illness would have on me. I had considered becoming a lawyer or a nurse since I wanted to help others in my earlier years. As her illness progressed and she was under the care of hospice, the people that came into our lives inspired me to pursue a career as a social worker. In our community of Santa Barbara and in Los Angeles where I helped my mother find Children's Hospital on her first time driving to the big city, I saw much that I felt could be improved.

The availability of health care for children in need of treatment for illnesses such as cancer, renal failure and many other health issues was not available locally. Availability of interpreters for families of various languages including Spanish were limited. Also, there were many Black families in the Eastside where we lived and several of my childhood classmates had parents who were Black and Latino. I say this because as people of color we are very diverse. I feel that it is best to ask a person how they identify themselves rather than make that decision for them. Financial resources were far and few for many in our community especially in certain neighborhoods. Many of us, as continues to be the case now in my opinion, helped our parents or grandparents navigate through the maze of the many systems such as health care, public assistance and employment. I feel that this gave me an increased awareness and also helped me along the path of life.

After graduating from high school, I attended UCSB. It was a different world and it took me a while to adapt; Storke Plaza was a place to listen to speakers and learn about different causes in the early 80's. The field of Sociology was fascinating to me and I graduated with a Bachelor's Degree. My father's lessons were put to good use as he had encouraged me to study very early in life. I knew that I had to forge ahead with my studies although our income and resources were very limited. I began to dream about attending graduate school and spent many hours both at the Eastside Library and in the UCSB library trying to find out about any financial resources to be able to reach my goal.

I applied and was hired as an instructional aide for the Migrant Program at Santa Barbara High School. With the Migrant Program, I had the opportunity to serve as a mentor for high school students, help students obtain their diploma and be an advisor for the Mecha Club. It was an excellent opportunity to work alongside community leaders. The community liaison at SB High was Ross Castro, he had come to California from Texas in his youth. Mr. Castro had been a member of the Brown Berets in his earlier years and was one of the founders of the Casa de la Raza. The high school youth and I myself in my early 20's learned about Chicano history from Ross Castro at a local and national level.

It was during this time that I was accepted to USC in the Master of Social Work program. I chose Policy, Planning and Community Development as my focus of studies.

My path kept leading me to increased involvement at the grassroots level and participation in local groups including the Cause Action Fund, the Pro Youth Movement and the Westside Neighborhood Group. I also worked on the passage of local school bonds and parcel taxes as a volunteer for the Santa Barbara Education Foundation. Local efforts to get the vote out in addition to social justice causes regarding immigrant rights, women's rights and tenant rights were of utmost importance to me.

I am often asked by friends and acquaintances how they can get involved in their community and make a difference. I suggest identifying issues that you are passionate about and signing up as a volunteer. The opportunity to network and learn from others is invaluable; the experience I have as a volunteer has been very fulfilling. Active participation in the League of Women Voters and attending the many forums they offer is very informative. The candidate forums are also very much appreciated. I invite all of our readers to be involved and to invite friends to participate. A positive side of Covid has been the possibility of participating from the comfort of our homes with Zoom.

My community involvement led me to the decision to run for the Santa Barbara Unified School District School Board because I knew that I could make a valuable contribution due to my experience and background. I had considered a seat on the school board for several years however I knew it would need to be at the right time in my life so that I could truly dedicate myself to the position and be effective in the capacity of school board member. I was also recently appointed as a Commissioner of the Housing Authority of the City of Santa Barbara. I am honored to be able to serve my community.
