# March is Women's History Month Time to Pass the Equal Rights Amendment

#### It's Personal—When Will We Ever Publish the ERA in Our Constitution?

For many of us the Equal Rights Amendment will not affect our day-to-day lives. But for many women in our country it can make a difference—especially if a woman finds herself on trial for defending herself against an abusive partner. Believe it or not, that's due to a carryover from old English law that says a man's home is his castle and he has rights (that women do not have)! It also affects equal pay, and equal educational opportunities—all women lose when this happens. And, for all of us, it will make a difference in how we view ourselves—that we have the same rights as men. We've been following the ERA for many years—50 or so. It was supported by both political parties when it was first passed in the U.S. Congress in the early 1970s. That picture has now changed and most elected Republicans do not support it.

The LWVUS supports the ERA. Under its Summary of Policy Positions, Social Policy, Equality of Opportunity Positions it states:

"Equal Rights: Support ratification of the Equal Rights Amendment and efforts to bring laws into compliance with the goals of the ERA. Support equal rights for all under state and federal law regardless of race, color, gender, religion, national origin, age, sexual orientation, or disability. "Education, Employment, and Housing: Support equal access to education, employment, and housing."


The two requirements for an amendment are that they be approved by a 2/3 majority in both houses of Congress and then that they be ratified by 3/4 of our states—that's it. Two years after that final ratification, the amendment is to become law. It took a long time to get that 38th ratification—until Virginia passed it in January of 2020. Some states have tried to rescind their ratification, but that has not been allowed for other amendments that have become law. And the time limits have been ignored for other amendments—one was even published after more than 100 years! But after that last required ratification by the state of Virginia, this amendment was blocked by the Trump administration with a memorandum sent to the National Archivist requesting that the Amendment be held and not published in our Constitution.

So, what's up with the ERA now? The Biden administration is leaving it to Congress to decide. A joint resolution that the ERA was validly ratified passed the House in February 2020 and again in March 2021. It has been blocked in the Senate with Republicans using the filibuster. According to Ms. magazine, "Democrats must either carve out an exception to the filibuster rule for the ERA joint resolution or convince 10 Republicans to vote to end the filibuster." So far, only two Republican Senators support the ERA joint resolutions: Lisa Murkowski of Alaska and Susan Collins of Maine. Election outcomes in the midterms next fall may make a difference in some Senate seats and that could swing the vote for the ERA in the Senate. It's likely that states other than California will have to make the difference—influencing voters across state lines is in order. LWVUS supports the ERA—they can help make a difference, too. 
The following presenters will be sharing their expertise to help us move forward:





# Who Will Be on the Ballot in June's Primary Election?

### 7th District State Assembly seat

So far, three candidates are running for the newly formed 37th District State Assembly seat: Gregg Hart, Gabe Escobedo, and Bruce Wallach.

#### **Sheriff**

Only the current Sheriff, Bill Brown, has filed to run, however Juan Camarena announced in December that he plans to run against Bill Brown.

#### 3rd District Santa Barbara County Board of Supervisors

So far, only one candidate, Laura Capps, has filed to run for this seat, but there are lots of rumors about others. The filing deadline is March 11, so stay tuned.

The State League is already hard at work getting Voter's Edge ready for June 2022. Voter's Edge is an online voter guide produced by LWVCEF in partnership with MapLight. It provides in-depth information about what's on your ballot. During the 2020 election season, 1 in 10 California voters used Voter's Edge to get a personalized list of candidates and ballot measures, including biographies, top priorities, campaign finance information, and more! And we plan to grow that number this year.

A dedicated group of volunteers across the state reaches out to candidates and gathers local election information to ensure voters have a one stop shop for all of their non-partisan ballot information and can confidently cast their ballots. #### **Easy Voter Guide**

## It's Time to Pass the Racial Justice Act for All


## From the League of Women Voters of California:

# **Inside the League**

This is a memo that was sent to the LWVSB Board after the announcement of Vijaya Jammalamadaka that she was resigning from her position as President.



#### **MEMORANDUM**

DATE: February 17, 2022

TO: Board of the League of Women Voters of Santa Barbara

FROM: Executive Committee, LWVSB

SUBJECT: Leadership Decisions Following Resignation of President

On February 14, 2022, the remaining LWVSB Executive Committee (EC) members--Vicki Allen, Pam Flynt Tambo, Anthony Moran, and Revae Moran--met to discuss how to proceed following the resignation of President Vijaya Jammalamadaka. This memo serves to inform the Board of the immediate decisions taken by the EC and some of the next steps to follow as we move forward.

To preface this, you should know that we are fortunate to have the support of Chris Carson, a former president of LWVUS and our local League coach. She has offered to provide guidance during this transition period. (She said,

"Please keep me in the loop. I've been with LWVSB for a very long time and my role here is more than simply an outside voice. In a lot of ways I feel like an honorary member.")

- 1. Leadership Structure
- a. LWVSB Bylaws specify that the EC will replace the President until such time as a majority of the Board elects a new President
- b. The 4 EC members then decided that, since no one was willing to immediately take over as President, the League will be governed by a Leadership Team composed of the EC.
- i. Many other Leagues govern through a Leadership Committee, Steering Committee, or other similar collective governing body in either the temporary or permanent absence of a President or Co-Presidents
  - ii. LWVSB Coach Chris Carson has confirmed that this is appropriate for our current situation
  - c. The EC then voted to add Joanie Jones to the EC
    - i. Joanie's wealth of experience is considered both invaluable and essential during this transition period.
    - ii. This decision will need to be ratified at the next Board meeting
- iii. Mary Rose, Chair of the Nominating Committee, will be informed of the strategy, and will be encouraged to work with the Leadership Team to nominate a candidate or candidates for President for the next term
- iv. Board members Ann Bailey and Emily Engel, who are members of the Nominating Committee, will be asked to coordinate with the Board to this end
- 2. Replacing Vijaya's Presidential Functions and Legal Requirements
  - a. LWVSB requires two signatures for all written checks
    - i. Anthony Moran, as Treasurer, signs all checks
    - ii. Joanie Jones will continue to have second signature authority
    - iii. The EC decided that Pam Flynt Tambo and Vicki Allen will also have second signature authority
    - iv. Revae Moran will not have the authority so as to avoid a conflict of interest
- b. Any contracts that require signatures will be approved collectively by the EC, with signing authority determined on a case by case basis
- c. Vicki Allen, as VP for Communications, will sign all LWVSB general correspondence, including donation thank you letters
  - i. All issue-specific correspondence will be signed by the appropriate VP for the subject matter
  - d. Since Vijaya was chair of the Budget Committee, her role needed to be replaced
    - i. Anthony is precluded from being Chair per the Bylaws
    - ii. Joanie Jones, as a current member of the Committee, was appointed Chair by the EC
  - e. Vijaya as President served as the League representative on certain Boards and organizations
    - i. The EC will try to identify which of these organizations needs immediate League representation.
- ii. The full Board will be asked to assist in this effort, and appropriate Board members will be asked to fill these roles as needed
- 3. Steps before the next Board meeting
- a. This memo serves to notify the Board how we are going to operate under a Leadership Team for the next few months
  - b. Revae Moran agreed to make changes to the LWVSB website to reflect the new leadership situation
  - c. League members will be notified of Vijaya's resignation in the next edition of the Channel Voter
- d. Anthony Moran, who has access to the League's Network Solutions account, will change all email addresses that were previously forwarded to Vijaya to a generic League website that he will monitor
- i. Additional changes will be made after consultation with Board members for example, SusCom will need to provide the EC with a new point of contact.
- 4. March 12th Board Meeting
  - a. Pam Flynt Tambo will Chair the meeting.
  - b. The EC will meet two weeks prior to the meeting to collectively generate an agenda.
